**MAREK SŁOMKA, Ph.D., D.Sc.** (JPII Catholic University of Lublin) is a priest of Lublin Archdiocese. He earned his postgraduate philosophical studies at the University of Freiburg (Department of Philosophy 1999-2000). He was the secretary to the Metropolitan Archbishop of Lublin (2002-2008). He was a recipient of the *Dangal ng UST, Hall of Fame Award* in 2016. His research interests include existentialism, intercultural/interreligious dialogue, philosophy of religion, and ethics.

**ALMA S. ESPARTINEZ, Ph.D.** (University of Santo Tomas) is a professor of philosophy at the De La Salle-College of Saint Benilde. A Fulbright Scholar-in-Residence (2010-2011), she taught at the Dominican University of California for a year and presented research papers in various states. After completing his Master of Divinity Studies (2001) and Postgraduate studies (2005) in Theology at the Lutheran Theological Faculty of Comenius University (LTF CU), Bratislava, he started focusing on philosophy and sociology of religion. He received his habilitation in religious studies at the Greek Catholic Theological Faculty, University in Prešov, Slovakia, and was inaugurated to a full professorship at the same faculty in 2018. He has served as a visiting scholar/professor Roanoke College, Salem, VA, taught and researched at the Comenius University in Bratislava, University of Zilina, and Constantine the Philosopher University in Nitra.
